The purpose of this policy is to provide students of SOMI with the guidelines related to changes in curricula, courses, catalog, and/or semester schedule

This policy applies to all students of SOMI.

IV. Definitions

Academic Calendar – The School academic year is defined as two standard terms (Fall, Spring) of 15 weeks plus a final examination period. A Summer term is defined as 8 weeks inclusive of the final examination period.

V. Policy Details
